At the same time, the fact that you have a colleague at all is unusual enough. "The reason we're looking for the way-out-there person is to try and get the staff to collaborate and make everyone a part of the process," says Tina Lee, state director of the Minnesota Partnership, a department of the state's Department of Employment and Economic Development. The state agency worked with its human-resources partners at the University of Minnesota and at the universities of St. Thomas and St. Cloud to find the person, and the recruits are expected to arrive at their respective campuses this month. "We're interested in attracting people who are going to be leaders and be competitive enough on the program in their organization that they have a career track there," Lee says. "Then we have them hit the ground running." Schumacher College, a small university with about a quarter of the enrollment of the University of Minnesota, has said no so far. But "there's definitely someone interested," says Deb Shultz, the school's associate director for its college of fine arts. The school will help the new recruits get settled, but it's not looking to hire them. Schumacher is just a few miles up 35th Street from the state's other campus, Carlson School of Management. The school's dean, Kailee Carlson, says she'd like to hire the people with fresh perspectives, especially with someone who works in a nonprofit—though she wants someone with a base in a large organization, too. "There's a lot of interest," she says. "It's such a great fit." If you're still up for the challenge, the state of Minnesota could use your talents. Lee says the Partnership is open to hiring someone to fill a niche role. Some of the new hires will end up at the nonprofits, but others will work with the newly hired recruit in the public sector. Lee points to the state's new presidential search firm, which is also recruiting new staff. "We asked the finalists: If you were one of those folks, what would you bring to the party?" There's a saying that the best way to predict the future is to create it, and Minnesota needs creative people.

Crist, Jr., Attorney General, Tallahassee, and Pamela J. Koller, Assistant Attorney General, Daytona Beach, for Appellee. PLEUS, J. Kendall James Caldwell appeals his conviction and sentence for aggravated battery and the denial of his motion for new trial following his conviction for possession of cocaine. He raises three issues on appeal. The only issue presented in this appeal is whether the State failed to present competent substantial evidence that the cocaine possessed by Caldwell was within the immediate control or control of his person, i.e., that he constructively possessed the cocaine, as opposed to joint control of the premises where it was found. There was evidence presented that Caldwell's mother rented the apartment where the cocaine was found. There was also evidence presented that Caldwell was a frequent visitor to the apartment. Therefore, Caldwell was not denied the right to be present at the trial or denied his right to an opportunity to confront witnesses as no witnesses testified as to the sole issue in the case, i.e., whether Caldwell had possession of the cocaine. Constructive possession is the "ability to exercise a conscious dominion or actual control over a narcotic." *Mussell v. State*, 848 So.2d 1143, 1146 (Fla. 5th DCA 2003)(citations omitted). Constructive possession requires (1) knowledge of the presence of the illicit drug, (2) the ability to maintain dominion or control over the illicit drug and (3) the intent to maintain dominion or control over the illicit drug. See e.g., *Vickroy v. State*, 815 So.2d 607, 609 (Fla. 3d DCA 2001)(citing *Moss v. State*, 613 So.2d 439, 440 (Fla. 1st DCA 1993)). Knowledge of the illicit nature of the substance is not required, see *State v. Gaford*, 538 So.2d 903 (Fla.
